The following information shall apply to the specifications and be incorporated into the bid.

1. This work does not include waterproofing for any of the horizontal walking surfaces on the ramps.
2. There is no work included on any surfaces inside the seating bowl.
3. An acceptable substitution is Evonik Protectosil AQUA-TRETE EM.
4. Add Bid Alternate Three and replace Bid Form B1-B4 with the following pages:

BID FORM

DESCRIPTION

This bid shall be priced according to the specifications. By signing this bid, the bidder agrees that this bid is made without any understanding, agreement or connection with any other person, firm or corporation making a bid for the same purpose and that this bid is in all respect fair and without collusion or fraud. Unsigned bids will be considered incomplete and subject to rejection. In addition, Bidder represents acceptance of the terms and conditions of the foregoing specifications and provisions.

BASE PROJECT BID

The Base Bid includes all labor, material and equipment to apply waterproofing to the exterior precast concrete and unpainted architectural PCU masonry at the four corner circulation ramps at Raymond James Stadium as specified, and as described. The bid shall be based upon the items included in the specifications. The Project Bid Total shall include all work as a completed project as described in the specifications including that which is not specifically listed on this form. Waterproofing of architectural precast concrete panels is not included in the scope.

ALTERNATE ONE

Alternate One includes all labor, material and equipment to apply waterproofing to the exterior precast concrete along the outside of the Upper Concourse.

ALTERNATE TWO

Alternate Two includes all labor, material and equipment to apply water proofing to the exposed exterior unpainted architectural PCU masonry at the service and main concourse levels, including center elevator enclosures (one each side).

ALTERNATE THREE

Alternate Three includes all labor, material and equipment for additional cost to provide water for cleaning of all surfaces to be waterproofed.
