always be relocated to another area of the property.

Question: Is there a storage yard for units that are pulled from Lots A-D on the premises – I

am assuming there is since it states that all units must be locked once cleaning has taken place from previous event in the Specifications – Under Scope – Letter

TSA Response: There isn't a designated storage yard on the property, but the units which are

pulled from Lots A-D after events can be placed with other units in the grass lots

on the property.

Question: Approximately how many Stadium Events require service between event days for

an event that is more than 1 day – I see Parking Lot Events (Car Sales and

Circus) require consecutive and multiple days service.

TSA Response: Between 2-5 per year.

Question: On Specification page 25 – Under Scope – Letter F – are you meaning hand

sanitizer?

TSA Response: Yes, hand sanitizer is what we meant.

Question: On Specification page 25 – Under Scope – Letter G – it does not mention in the

quantity any hand wash stations, are the estimated quantity of units including hand wash stations? If so, please give approximate needs per Stadium Event.

TSA Response:	We don't typically request that hand wash stations are provided for stadium events. However, some parking lot events will specifically request them. I'd estimate that approximately 10 events per year will want between 1-3 hand washing stations.	
Question:	On Specification page 25 – Under Scope – Letter H – please explain emergency cleanings as far as reason a call would be made please	
TSA Response:	This happens on very rare occasions at the request of a client.
