The following information shall apply to the specifications and be incorporated into the bid.

1. The bid security for this project is waived.
2. The bid shall include the material and labor to install the pedestal for the card reader.
3. Tampa Sports Authority is a tax exempt organization. No taxes will be required in the bid.
4. The opening device shall be a Viking G-5.
5. An allowance of \$300.00 for permitting shall be included in the bid. A revised bid form is attached and the allowance amount shall be filled in by the bidder.
6. The extent of professionally certified drawings required by the City of Tampa has not yet been determined. However, if required, TSA will work closely with the contractor to provide the requested documents. The contractor will produce the documents to TSA for inspection and approval and TSA will cover the cost to sign and seal by utilizing its own labor to do so. The contractor will then be responsible for submitting to the City all certified permitting documents, application forms and the payment for the permitting fee. The contractor may submit a separate invoice for reimbursement of the fee prior to the commencement of construction.
