If there are multiple items, please submit up to two (2) best match/or equal products by making a copy of the Bid Proposal (Page 22) and submit both pages with one (1) completed bid proposal packet. You must submit the specs to prove your submittal is an "equal to" product if different from what the Authority is requesting in the bid specs. Keep in mind that the Authority may ask for a sample product to assure it works for the Authority prior to making a final award decision.

Question:

When is the due date for **delivery** of the (190) LED Lights?

TSA Response:

Within 30 days of award. If delivery will take longer than 30 days, an arrangement can be made with the Authority after proper notification from the vendor.

Bid Document calls for Florida Business license to submit a bid. The bid is only for delivering the Lights and no installation. We are a Georgia Company can we still submit the BID and qualify for the BID.

TSA Response:

The Authority requires any company we do business with to be registered with the State of Florida's Department of Corporations for both materials and services.

Page 3 Addendum #2 Bid #17-05

Question:

Please verify how long the prices for this bid are to be valid.

My understanding is that this is a one-time purchase of 190 fixtures but pricing needs to be valid for a period of time to cover additional fixtures if required.

TSA Response:

Per Bid Proposal Page 22:

"The Proposer, in submitting this bid, guarantees the following pricing for forty-five (45) days unless an extension of time agreement is reached between the Proposer and the Authority." This is a one-time purchase. Thus far, we will not need more than 190 units. If the Authority decides it needs additional fixtures, it may be decided prior to the final award (issuance of a Purchase Order) or within the 45 days listed above.

Question:

Could you please advise if an equivalent LED fixture must be DLC Certified?

TSA Response:

Yes. It must be DLC Certified.
