

## ADDENDUM No. 2 – (August 24, 2018)

ADDENDUM TO: Pest Control Services, RJS

TO BIDDER: This addendum is an integral part of the Bid file under consideration by you as a bidder in connection with the subject matter identified above. For the purpose of clarification the following additions, changes, modifications and replacements noted below have been made to the Bid and have been made to the Bid file which bears the above title.

Bids submitted shall conform to these additions and modifications noted herein and including all issued addendums.

### Clarifications/Questions & TSA Responses:

My questions are if you could provide me with information on how this process is currently being done? **Currently we have the Bird Guard system installed on all of our light towers which operates throughout the year (except event days) which is used to deter birds within the facility. Our current pest control company has yet to perform any treatment for the control of the Pigeon population and the previous company used a gel type application.** Being that Avitrol, as listed on the label, is a “restricted use” product, could you also provide information on the bait boxes as mentioned above? (Meaning what they look like and how the product is being introduced) Avitrol, is also a product that again, according to the label, needs to be picked up every day. **PVC baskets and all products used by the contractor shall be EPA registered and applied in accordance with Federal regulations and product label instructions** so; do you happen to know the technician’s schedule for this specific service? **Refer to the scope and requirements related to the inspections which are performed by the pest control company to identify an area of concern which would require pigeon control treatment by the contractor to be performed in a designated area. An area may also be identified by the Authority and provided to the contractor in need of treatment.** Finally, could you provide information on how they are only targeting pigeons with their current process? **Refer to the scope and requirements as the measures taken by the pest control company are to control the Pigeon population only if and when required.**

Essentially, my only/main question is in regards to how they are currently handling the specific pigeon control portion of the service, as there may be better and more effective options **Alternative measures if required for Pigeon control may be submitted and applied if administered in accordance with Federal regulations and product label instructions.**
